

JULIE KNUTSON TRAINING WORKSHOP:

Building a Finished Upland Pointing Labrador

Julie Knutson, nationally acclaimed dog trainer and author of "Training the Pointing Labrador" will be conducting a workshop with 2 full days of individualized one-on-one instruction for members of the Northwest Pointing Labrador Club. Due to the amount of time it takes to cover each topic, dog/handler teams will be limited to the first 12 individuals who register. However, an unlimited number of participants may register to attend the workshop without their dog. Only members who have NOT previously participated with their dog in one of Julie's workshops may register as a dog/handler team.

Cost: \$225 for dog/handler team; \$100 for participant without dog. This includes 4 chukar per dog/handler team (if your dog requires more, they can be purchased for \$12.50 apiece), plus lunch, snacks, and beverages.

Dates/Sessions:

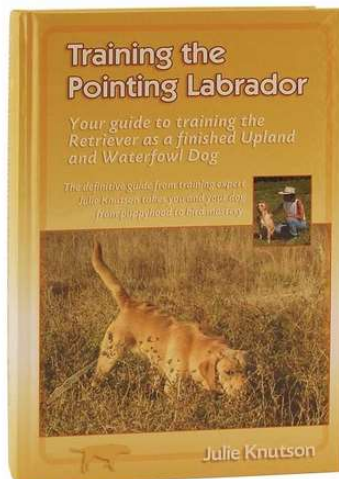
- Saturday June 26, 7 am – 5 pm (lunch included)
- Sunday June 27, 7 am – 4 pm (lunch included)

Location: Sauvie Island, OR. As this is private property, address and full directions will be sent to participants after registration is received.

Food/Drink: The Club will provide lunch on Saturday and Sunday, as well as snacks and beverages.

Lodging: Dry camping will be available for \$10/night. Toilets are on site. Lodging that is within 20 minutes of the site can be found at Best Western Oak Meadows (St. Helens, OR) or downtown Portland.

Rules: (1) Only the first 12 dog/handler teams whose applications and fees are received will be eligible to participate in the workshop. (2) Dog/handler teams are not considered registered until payment is received in full and they have been notified by e-mail that they are registered. (3) Only 1 dog per family may be registered. (4) Registered dog/handler teams must be available for the entire workshop (Saturday morning through Sunday afternoon). (5) Dogs in heat will not be permitted on site. (6) For applications and fees received after the 12 dog/handler team deadline, checks will be returned to the applicant or if they elect to become non-dog participants instead, the difference in cost will be refunded. (7) Only dogs participating in the workshop will be allowed during the workshop. Other dogs that are traveling with you must stay with your car or camper. All dogs should remain in their vehicles, crated, or on stake-out during workshop hours; owners must ensure their dogs remain quiet. All dogs should remain leashed unless they are actively working with Julie. (8) Please pick up your dog's waste. Garbage cans will be on site. (9) Cancellations with full refunds will be permitted up until June 19. Thereafter, there will be no refunds issued.
